**Subject: Putting up of Final Electoral Roll for the next election to the Bar Council of Punjab and Haryana to be held on 1<sup>st</sup> November, 2018 and 2<sup>nd</sup> November, 2018.**

Dear Sir,

This is to intimate you that as per schedule of the Election programme approved by the General House of the Bar Council of Punjab and Haryana in its meeting held on 1<sup>st</sup> July, 2018, I am to forward herewith a copy of the extract of relevant portion of the final Electoral Roll relating to your Bar Association, which has been prepared under Section 3 (2) (b) of the Advocates Act, 1961, read with rules 3 and 4 of the Rules made by the Bar Council of India as contained in Chapter-I, Part III of the rules, Bar Council of India Certificate and Place of Practice (Verification) Rules, 2005 and All India Bar Examination, Rules 2010. Its complete copy has also been put up on the Notice Board of this Bar Council on 27<sup>th</sup> August 2018. As per decision of the Bar Council taken on 1<sup>st</sup> July, 2018, the complete final Electoral Roll has also been put up on the official website site of the Bar Council i.e. [bcph.co.in](http://bcph.co.in).

As per provision of Rule 13 (ii) of the Bar Council of Punjab and Haryana Election Rules 1968, the entries in final electoral Roll and no addition /alterations, omission, can be made there to excepting such alternations as may be necessary with reference to the death of an advocate or the removal of the name of an advocate for misconduct, an order of suspension for misconduct or a voluntary suspension from practice till the date of election.

I am also to say that the next election of twenty-five Members of the Bar Council of Punjab and Haryana shall take place on the 1<sup>st</sup> November, 2018 at Chandigarh and on 2<sup>nd</sup> November 2018 in the States of Punjab and Haryana. Necessary information and other particulars in connection therewith, have been notified separately. I am to request that the enclosed copy of relevant portion of the Final Electoral Roll may be put up on the Notice Board of your Bar Association for information and perusal of the Advocates practising within the jurisdiction of your Bar Association.

I am to further add that the names of President and Secretary of the Bar Association with their full residential addresses along with their Telephone Numbers/ mobile Numbers or email addresses, if any, be intimated to this office by return of post, for further correspondence, if any, required.
