4	Nomination of Returning Officer/Election Committee by Bar Association as per their own Rules/ by laws and sending the intimation to the State Bar Council by registered post.	On or before 30.09.2021
5	Date of Election	17th December 2021 (Friday)

The present office bearers of Bar Associations are requested to take all necessary steps to ensure the implementation of the rules in its letter and spirit by following principle of one vote one Bar Association.

In case any advocate wants to change place of practice, he/she may apply to the Bar Council on or before 20.10.2021.

The Returning Officer, so appointed by the respective Bar Association is also requested to send the intimation of the result of the elections to the Bar Council on conclusion of its election process. Compliance of the Rules would be highly appreciated.

Note: In case a particular Bar Association fails to make compliance well within time then the Bar Council will appoint Adhoc Committee who will take over the entire control of the Bar Association and will get the elections conducted under its supervision.
