The Bar Council has received one communication from Mr. Kultar Malik, enrollment No. P-441/1992 for inclusion of his name in the voter list of elections. He has stated that he has paid the fees through his son Mr. Prikshit Malik and therefore his name has not been included in the voter list.

Similarly, we have received another application from Sh. Gulab Singh Poars Advocate having enrollment no. P-2520/2012 who has not been allowed to cast vote because of the reason that he has not passed AIBE. Since, he has done has law long back in the year 1985 and after retirement he got the license. Therefore, he is also entitled to be included in the voter list.

One another fact came to the notice of the Bar Council that certain advocates who have been enrolled with Delhi Bar Council have been wrongly included in the voter list of District Bar Association, Rohtak and as per our rules they cannot be allowed to cast votes in the elections of the Bar Association until and unless they may have got transferred their names to the Bar council of Punjab and Haryana, therefore, their names are to be deleted from the voter list.
