As per the decision of the Bar Council taken on 10.11.2025, the complete Final Electoral Roll has also been uploaded on the official website of the Bar Council, i.e. www.bcpn.co.in.

As per the provisions of Rule 13(ii) of the Bar Council of Punjab and Haryana Election Rules, 1968, the entries in the Final Electoral Roll are final and no addition, alteration, or omission can be made thereto, except such alterations as may be necessary with reference to the death of an advocate, or the removal of the name of an advocate for misconduct, an order of suspension for misconduct, or a voluntary suspension from practice till the date of election.

I am also enclosing herewith a copy of the relevant portion of the Final Electoral Roll concerning your Bar Association, and the same may please be displayed on the Notice Board of your Bar Association and circulated on your Bar Association WhatsApp group, as well as through any other convenient mode, for the general information of all Advocates/Members practicing within the jurisdiction of your Bar Association.
