NOTICE FOR ELECTION

Dated 30th January, 2026

(Notification No. 05/26)

(As per the directions of the Hon'ble Supreme court of India , vide order dated 30.11.2025 in Writ Petition (Civil) No. 1319/2023 M. Vardhan Vs Union of India & Anr.

It is hereby notified for the information of all concerned that under Rules 4 and 6 of the Rules made by Bar Council of Punjab and Haryana, under Section 15 of the Advocates Act, 1961, with the approval of the Bar Council of India, in view of the order of the Hon'ble Supreme Court of India the election of the Bar Council of Punjab and Haryana has fixed for **17th March, 2026 at U.T. Chandigarh and 18th March 2026, in the States of Punjab and Haryana, as dates for the Election of twenty three Members to the Bar Council of Punjab and Haryana, for the States of Punjab, Haryana and Union Territory of Chandigarh.** The said election shall be by secret personal ballot paper and by single transferable vote, at the Polling Stations which will be set up in all Districts, Tehsil/ Sub Divisional Headquarters where there are at least seventy-five duly enrolled voters. The Voters enrolled at other places less than 75 shall vote at the nearest polling Station.

In view of the proviso to Section 3 (2)(b) of the Advocates Act, 1961 and rule 4 (A) of the Bar Council of India Rules and 49 (ac) and (ae) of the said Act, the number of seats to be filled from amongst the candidates who have been on the Roll of the State Bar Council for less than ten years shall be twelve. There shall, however, be no limit to the number of elected candidates who have been on the Roll of the State Bar Council for at least ten years who could be declared elected. In computing the said period of ten years in relation to any such person, there shall be included any period during which he/she has been an advocate enrolled under the Advocates Act, 1961 and / or on the Roll of any other State Bar Council, prior to transfer to the Roll of this Bar Council u/s 18 of the Advocates Act, 1961.

Every candidate for election as a Member of the Bar Council shall be proposed by one voter and seconded by another voter. The nomination paper shall be delivered to the Returning Officer either personally or through an agent duly authorized by the applicant in writing or be sent by registered post so as to reach to the Returning Officer between **10.00 AM. to 4.00 PM. on 10th February, 2026 and 11th February 2026**. Such nomination paper shall further contain the acceptance by the candidate to serve on the Bar Council, if elected.

Each nomination shall specify the date of enrolment as an advocate of the candidate and the period for which his/her name has been on the Roll of State Bar Council under the Advocates Act, 1961 with full particulars thereof and serial number in the final Electoral Roll.

Nomination paper shall be available w.e.f. 01.02.2026, for sale for a sum of Rs.5000/- (Rupees five thousand only) maximum 4 (four) nomination papers will be issued per candidate.

Every nomination paper shall be accompanied by a non-refundable fee of Rs. 1,25,000/- (Rupees one lakh Twenty five thousand only) by way of Bank Draft in favour of "Bar Council of Punjab and Haryana" payable at Chandigarh or online.

Provided as per order dated 05.01.2026, passed by the Hon'ble Supreme Court of India, in the matter of Pankaj Sinha Vs Bar Council of India & ors. in Writ Petition (s) (Civil) No. (s) 1261 /2025 , if any advocate belonging to the especially abled category, to contest the election of the Bar Council shall be required to pay symbolic nomination fee of Rs. 15,000/- by way of Bank Draft in favour of "Bar Council of Punjab and Haryana" payable at Chandigarh or online, instead of Rs. 1,25,000/-.

Note ; As per order dated 16.1.2026 of the Hon'ble Supreme Court of India, there is no separate Ballot paper for the women advocates contesting the Election of Bar Council of Punjab and Haryana, Chandigarh-2026. A common ballot paper will be there for all.
