- (iii) To prepare and implement scheme for giving assistance to the members and their families in distressed circumstances.
- (iv) To maintain a library of legal literature and of other subjects likely to be useful for the Members of the Bar Association.
- (v) To provide a meeting place for the members for study & discussion of Law and to provide kind of necessities amenities to the members of the Bar Association.
- (vi) To bring to the notice of the Bar Council of Punjab & Haryana, Bar Council of India, Hon'ble Punjab & Haryana High Court, Hon'ble Supreme Court of India or the Central or the State Govt. Matter effecting the legal profession in general and member of the Bar Association in particular.
- (vii) To promote the growth of the Bar Association for the purpose of effective implementation of the welfare schemes framed by the Bar Association as well as Bar Council.
