CONSTITUTION

Whereas it is expedite to make written constitution of Bar Association, Zira. It is approved as under:-

1. It will be known as Bar Association, Zira.
2. It shall come into force by 7.2.1978.
3. The Bar Association, Zira, shall consist of all the members on rolls on the 1st December of every year and the members enrolled till the 1st December of every year.
4. Any Advocate wishes to become member of the Bar, shall apply to the President for the purpose and he will be admitted if he is sponsored by at least two existing members of the Bar.
5. Every new member will have to pay Rs.50/- as Admission fees.
6. Every member of the Bar shall pay Rs.6/- or any other amount as modified from 1st January, 1979.
7. The Bar shall have the following office bearers.
 - (1) President
 - (2) Secretary.
8. The General house shall meeting at least once in three months and also when requisitioned by the President or three members of the Bar.
9. The office bearers shall be by elections.
10. The election shall be held in every year on the 7th January at 9.30 A.M. in Bar room. If the 7th January happens to be holiday the next working day.
11. The voter at the time of election shall fulfill the following conditions:-

- (a) He should be on the rolls on the 1st December of every year and
(b) He should have cleared all dues occurring up to 30th November.
12. The President shall preside on every meeting and in his absence any member elected by the house to preside for the meeting. The President shall have the right of casting vote except during the election.
13. That office bearer shall hold office till the next election.
14. Any of the office bearer shall be removable by the 3/4th majority of the members enrolled and having the right to vote.
15. In case of death of office bearer, removal or resignation, the vacancy shall be filled by election within one month. The date shall be fixed by the surviving office bearer. Such elected office bearer shall hold office for the remaining period.
16. Procedure for the election :-
- (a) Nomination paper to be filed with the President/Secretary up to 4 P.M on 26th December of the year.
- (b) Nomination papers shall be accompanied by a security of Rs.50/- refundable in case of withdrawal before 30th December of the year or if he secures 1/4th votes of the total votes polled.
- (c) The nomination papers would be presented to the President/Secretary who will publish the list of nomination papers received by him on the 26th December and also publish the list of finally contesting members on the 30th December.

Afterward this constitution has been amended from time to time by various resolutions passed by the Bar unanimously as under:-

17. The clause No.3 has been substituted as under:-

The Bar Association shall consist of all the members on rolls, who will be enrolled as member of the Bar Association, Zira will not be entitled to vote for that year and shall be eligible to vote in the next years. The member of an other Bar association will not be enrolled as member of this Bar. The entry in the Bar for a new member shall be with simple majority and above rules shall not be changed unless 2/3 enrolled members votes in favour of it.

18. The clause 5 of the Constitution is amended as under:-

“ Every new member will have to pay Rs.250/- as admission fees”.

19. The clause No.6 amended as under:-

“ Every member of the Bar shall pay Rs.40/- or any other amount as modified from time to time vide resolutions passed by the Bar.
