RULES of the

BAR ASSOCIATION, JALALABAD (W)

- 1. <u>Name</u>: The Association shall be called "<u>Bar Association</u>

 Jalalabad (w) "
- 2. <u>Person eligible for Membership</u>: Every Advocate who got the Licence from Bar Council of Punjab Harayna shall be eligible to be enrolled as the member of the Bar Association, Jalalabad.
- 3. <u>New Membership</u>:-Every Candidate who apply for the membership of Association subject to fulfilment of other eligibilty will have to submit an application proposed by the two eligible members (having right to Vote) of Association shall be addmitted by General House. Such person shall also pay Rs. 800/- as membership fee together with one month subscription.
- 4. <u>Monthly subscription of the member</u>: Every member of Bar Association shall pay Rs. 40/- (fourty only) per month as subscription and such member has to pay any amount, so levied by Executive Committee of Bar Association or General House.
- 5. <u>Disqualification</u>:- Any member of the Assosciation who fails to clear his outstanding amount on the relavent date so fixed by association continuance for the period two year will cease to be the member of Bar Association.
- 6. <u>Meeting</u>:- The meating of General house shall be convened quarterly to discuss of general matter.
- I. In case of any requisition by at least ten member of the association and disclosing the agenda in such an event the meeting of General House will be convened.
- II. The President, Secretary and the majority of the executive members can also call for the meeting of General House disclosing the agenda on this behalf.
- 7. **Quarum of meeting**:- On third of the eligible members shall for the quarm for the meeting of General House.

That any resulation or any other matter shall be deemed to have been passed if supported by the majority of member present at the time of meeting of General House.

- 8. Office Bearer of Association: There shall be one President, One Vice-President, one Secretary and one treasure of the Bar Association, Jalalabad (w) and there shall be a executive committee consisting of Five members who would be nominated by the President & Secretary and in addition to these Six members the out going president shall be the member of the executive committee for one year i.e. the succeeding year. However the strength of the executive may be increased from time to time depending on strength of member of Bar Association. Any decision if taken by the executive committee and office bearer may be a nulled by General House.
- 9. <u>Election of Office Bearer</u>:-The election of the aforesaid office bearer

shall be held every year and not later than in the month of

- Eligibilty of Voter: Every member of the Association who is a permanent resident of any area which fall with in the limit of tehsil Jalalabad / Assembly constituancy of Jalalabad (w) shall be competent to cast his vote in the electionn of office bearer of Bar Association. Provided such member is not a defaulter of any amount which may be found outstanding against such member on the relavent date so fixed by the Bar Association.
- Maintenance of Accounts :- The Treasurer shall maintain the proper accounts regarding the income and expenditure of the Bar under the supervision of President.
- Audit of Accounts :- The account of Bar Association shall be subject to audit by the two auditors appointed by General House which shall be made in the first week of Oct. and treasurer shall submit the accounts books to the said Auditor at relavent time.
- Proceeding Record :- Secretary of the Bar Association shall write the minutes of the proceeding of General house in proceeding book.
- Appointment of Bar Atendent and Staff: The president, in constituance with executive committee will appoint necessary staff for the maintance and running the Bar room/ Library or any other matter of Bar Association on Contract Basis which shall not exceed more than one year.
- That every member of Bar postively will abide by the rules so framed by the Bar Counsel of Punjab & Haryana, Chandigarh and applicable to the members of this Bar.
- That no books of library of the Asso-Maintenace of Library :ciation shall be issued to any body nor any body would be allowed to take out book from the limits of Library.
- Any member of the Bar Association who ever violates the decision of Bar Association in case of strike shall be fined Rs. 1000/- to 5000/- at first time, Rs. 5000/- in second time. The proxy counsel shall be presented in the court on strike if he violates the decision third time shall be disqualified for one year.
- In the election of Bar Asssociation the nomination fee for the Post of President shall be Rs. 1500/-, for the Vice President Rs. 1000/-, for the Secretary Rs. 1000/- and for the post of Cashier Rs. 500/- shall be charged.
- That any new member enrolled shall have no right to vote in the election of office bear if he obtains the membership with in a periond of six months preceeding the date of election. His enrollment must be beyond six month from the date of election.
