This is to inform you that the elections of the Bar Associations are to be held as per **The Bar Association** (Constitution and Registration) Rules 2015 (as amended upto date) which mandates certain timely steps to be undertaken to ensure fair Election and smooth transition of Bar Associations. Since the next annual elections of the Bar Associations in the States of Punjab, Haryana and U.T. Chandigarh, is due, the schedule of election for the term of 2024 is as under:-

The present office bearers of Bar Associations are requested to take all necessary steps to ensure the implementation of the 2015 Rules (as amended upto date) in its letter and spirit, by following principle of 'ONE VOTE ONE BAR'.

The voting rights shall be confined to only those members who are enrolled with the Bar Council of Punjab & Haryana. Any advocate, who is enrolled with any other State Bar Council and wishes to vote in these elections may apply for transfer u/s 18 of the Advocates Act, 1961 and will only be eligible to vote if the entire procedure of transfer is completed before 31.10.2023, as per norms. Further, as per circular No. /2013(Council) dated 12.04.2013 of the General House of Bar Council of India, only those advocates who have passed their All India Bar Examination (AIBE), shall be entitled to vote (this is not applicable to voters who are enrolled/have passed law prior to June, 2010).

Important; The advocate who is enrolled with Bar Council other than Bar Council of Punjab and Haryana shall not be included in the voter list by any Bar Association and if any such name exist that shall automatically be stand deleted and such advocate shall not be allowed to participate in any election and to cast his/her vote.

The Returning Officer or Election Committee, as so appointed by the General House of respective Bar Association, or as per their own bye-laws, are requested to send the intimation of the result of the elections to the Bar Council on conclusion of its election process.

- Note 1 All the Hon'ble Members of the Bar Associations can deposit/clear their dues/subscription, well in time against valid receipt/proof, by way of RTGS or NEFT or IMPS or UPI or any other electronic mode of transfer of money (via individual accounts only) or through bank draft against valid receipt of Bar Association. Any bulk payments by candidates/agents (Except blood relation) will not be allowed and same will be considered as violation of Rules. The President/ Secretary and other office bearers are directed to publicly display (on Notice Boards etc) and circulate the Bank account/QR code numbers of Bar Association's henceforth (also circulate via messages), and make necessary arrangements to accept payments via RTGS, UPI, QR Code etc. in case of cheque, such cheques must be cleared before 31.10.2023 otherwise the payment through cheque shall be deemed to be doubtful.
- Note 2 In case any particular Bar Association fails to make compliance well within time then the Bar Council will appoint Adhoc Committee which will take over the entire control of the Bar Association and will get the elections conducted under its supervision, as per norms.
- Note 3 Any kind of parties, large gatherings by the candidates or their agents are strictly prohibited and any such large gatherings, if so reported, may lead to cancellation of candidature. No election/vote appeal pamphlets or flexes will be allowed to be fixed on the Chambers or Court premises, along with limited distribution of the same, ensuring 'PAPERLESS GREEN CAMPAIGN'. The Bar Council requests all to cooperate to ensure free, fair, environment-friendly and sustainable elections.
- Note-4 No cash payment should be paid by members nor should it be received by the Bar Association and even payment though cheque not presented and cleared before 31.10.2023, shall be at the risk of the concerned member
- Note 5. Since the approval of amendment in "The Bar Associations (Constitution and Registration) Rules, 2015" sent to Bar Council of India, vide letter No.3786/23 dated 29.9.2023, as yet has not been received, by the State Bar Council, the present election schedule under the existing rules is being issued.
