It is further alleged in the complaint you have also distributed pamphlets for your advertisement using the Govt. Logo 'Aajadi Ka Amrit Mohatsav'.


The Committee has considered the above noted complaint which is accompanied by copy of calendar allegedly distributed by you which contains the photograph's of dignitaries referred to above. In one of the calendar you have mentioned court "EK BAAR PHIR SE".

The Committee has considered the complaint and find that by using the photograph of Hon'ble CJI, on the calendar distributed by you, you have made an attempt to unfairly influence the voters by showing as you have the backing of Hon'ble Chief Justice of India.

The Committee is of the view that by doing this act you have attempted to gain cheap popularity or to obtain any self-gain unfairly and in an illegal manner which amounts to violation of the Code of Conduct issued by the Committee on 29.11.2025.

You are hereby called upon to show cause as to why appropriate action be not initiated against you for violating the Code of Conduct issued by the Committee as referred to above. Your may submit your reply within 3 days from the receipt of this notice, failing which further appropriate action will be taken by the Committee, which may include some drastic step to stop the misuse of Code of Conduct issued by the Committee.


It is prays as under:-

So, through this application, I am request to you, to initiate strict legal action against Raj Kumar Chauhan, Advocate and he may kindly be restrained to contest in the above said election, in the interest of justice.






